MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

JACK DOUGLAS BRYANT,

...(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Seventeen

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Avon Drive, being shown and designated as Lot No. 83, on plat of Avon Park, recorded in the RMC Office for Greenville County, S. C., in Plat Book "KK", at Page 71, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwesterly side of Avon Drive, at the joint front corner of Lots Nos. 83 and 84, and running thence S. 84-18 W. 175 feet to an iron pin; thence running N. 5-42 E. 90 feet to an iron pin; thence running N. 84-18 E. 175 feet to an iron pin on the northwesterly side of Avon Drive; thence with the northwesterly side of Avon Drive S. 5-42 W. 90 feet to the point of BEGINNING.
