(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Eighteen Hundred - - - - -

DOLLARS (\$1800.00), with interest thereon from date at the rate of **Seven (7%)** - per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about $1\frac{1}{2}$ miles northward from Chick Springs, on the northwestern side of Jonquil Lane and being shown as Lot No. 18 on plat entitled "Subdivision for Columbia Investment Co." prepared by Piedmont Engineers and Architects dated July 9, 1965, and recorded in the R.M.C. Office for Greenville County in Plat Book KKK at Page 73 and having such metes and bounds as shown thereon, said lot fronting 100 feet on the northwestern side of Jonquil Lane and being 150 feet in depth on each side and 100 feet across the rear.
