Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in the County of Greenville, State of South Carolina, being shown as Lot No. 15 of Ogden Acres, plat of which is recorded in the RMC Office for Greenville County, S. C., in Plat Book BBB, Page 27, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Ogden Drive at the joint front corner of Lots 14 and 15 and runs thence along the line of Lot 14 S. 33-40 E., 129 feet to an iron pin; thence S. 56-10 W., 130 feet to an iron pin; thence along the line of Lot 16 N. 33-40 W., 105 feet to an iron pin on traffic circle on Ogden Drive; thence with said circle, the chord of which is N. 34-16 E., 64.6 feet to an iron pin; thence with Ogden Drive N. 56-10 E., 70 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
