account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly
paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted,
bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and as-
signs:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and
being in the State of South Carolina, County of Greenville, situate on the East side of Parkwood Avenue and
being known and designated as Lot No. 57 in a subdivision known as Northwood as shown on plat
recorded in the R. M. C. Office for Greenville County, S. C. in plat Book J. page 102, and
more particularly described according to survey and plat by Piedmont Engineering Service,
August 1954, as follows:

BEGINNING at an iron pin on the east side of Parkwood Avenue, Front Corner of lots Nos. 56
and 57; thence with the line of said lots S 73-28 E. 151.4 feet to an iron pin; thence N. 37-00
E. 75 feet to an iron pin in the line of Lot No. 58; thence with the line of said Lot N. 71-12 W
174 feet to an iron pin on said Avenue; thence with said Avenue; S. 19-30 W 68 feet to the
beginning.

fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right
and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances
