NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that piece parcel or lot of land situate, lying and being on the Southwestern side of Crain Aven., near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 2 of Central Realty Corporation property, according to a plat thereof made by Pickell & Pickell, November 22, 1946, recorded in the R. M. C. office of Greenville County in Plat Book "P" at Page 99, having the following metes and bounds to wit:

Beginning at a stake on the Southwestern side of Crain Ave., approximately 160 feet from the Northwestern intersection of Crain Ave. and Hampton St., at the corner of Lot No. 1 according to said plat, and running thence along the line of said Lots 45-15 W. 215.6 feet to a stake at the rear corner of Lot No. 1; thence N. 25-30 W. 62 feet to a stake at the rear corner of Lot No. 3; thence 45-45 E. 215 feet to a stake of the Southwestern side of Crain Ave., thence along the said Crain Ave; S. 25-30 E. 60 feet to the point of beginning

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
