WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Ten Thousand and No/100ths**-----

DOLLARS (\$10,000.00) , with interest thereon from date at the rate of **six**-----
per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northwestern and Western sides of Claxton Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 97, as shown on a plat of Farmington Acres, prepared by Carolina Engineering & Surveying Co., dated December, 1962, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book RR at pages 106-107, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Claxton Drive at the joint front corner of Lots Nos. 97 and 98, and running thence with the line of Lot No. 98 N. 37-15 W. 150 feet to an iron pin; thence with the rear line of Lot No. 96 N. 52-45 E. 111.5 feet to an iron pin on the Westerly side of Claxton Drive; thence with the Westerly side of Claxton Drive S. 32-46 E. 125.6 feet to an iron pin in the curve of Claxton Drive, the chord of which is S. 10-0 W. 36.5 feet to an iron pin on the Northwestern side of Claxton Drive; thence with the Northwestern side of Claxton Drive S. 52-45 W. 75 feet to the point of beginning.
