TO ALL WHOM THESE PRESENTS MAY CONCERN: WE, JOSEPH D. PINCKNEY & HARRIETT H. PINCKNEY of Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 15 on plat of Poplar Circle subdivision recorded in the RMC Office for Greenville County, in plat book QQ page 183 of the RMC Office for Greenville County, S. C., said lot having a frontage of 61 feet on the northeast side of Plum Drive, a depth of 142 feet on the northwest side, a depth of 150 feet on the southeast side, and a rear width of 60 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
