TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Byron P. Leverette and Edna T. Leverette, of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

ALL that piece, parcel or lot of land situate, lying and being on the northern side of Whiller Drive and being known and designated as Lot No. 15 on plat of PARK LANE TERRACE, Greenville County, South Carolina, recorded in the R.M.C. Office for Greenville County in Plat Book "1A", page 47.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
