"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, at the northwestern corner of the intersection of Kent Lane and County Road, and being known and designated as Lot No. 50 on plat of Vista Hills recorded in the R. M. C. Office for Greenville County in Plat Book "P", at Page 149 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwestern corner of the intersection of Kent Lane and County Road and running thence along the northern side of County Road S. 77-50 W. 177.9 feet to an iron pin; thence N. 1-50 W. 106 feet to an iron pin; thence along the joint line of Lots Nos. 49 and 50 N. 88-10 E. 175 feet to an iron pin; thence along the western side of Kent Lane S. 1-50 E. 75 feet to the point of beginning.
