All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being at the intersection of Terrentine Circle Road and a 50 foot street, being known and designated as Lots Nos. 1 and 2 on plat of Property of Donald Lafoy Pittman, prepared by Terry T.
