3. All that piece, parcel or lot of land situate, lying and being in Oaklawn Township, Greenville County, South Carolina, on the road leading from the Old Plezer Road to United States Highway No. 29, and, according to plat made by J.D. All that piece, parcel and tract of land lying and being in the County of Greenville, State of South Carolina, Oaklawn Township, containing approximately 70 acres, and having the following metes and bounds, according to a plat of property of H. P. Beam by C. O. Riddle, L. S., dated August, 1954: BEGINNING at a point in center of S. C. Highway No. 8, at corner of Jim Beam and running thence with his line S. 45-5 W. 1617 feet to stone; thence S. 45-45 E. 1881 feet to a point in Greve Creek; thence with the center of Grove Creek as the line with the following traverse courses and distances: N. 49-15 E. 93 feet; N. 29-15 E. 236.3 feet; N. 49-30 W. 333.3 feet; N. 46-45 E. 424.4 feet; N. 78-30 E. 729.3 feet; N. 1-30 W. 50 feet; N. 59-15 E. 291 feet; N. 38-30 E. 250 feet; N. 16 E. 538 feet to a point in center of Grove Creek and under bridge spanning S.C. Highway No. 8; thence with center of said S. C. 5. All that piece, parcel and tract of land lying and being in Oaklawn Township, Greenville County, South Carolina, containing 4.67 acres, more or less, according to a resurvey made by C. O. Riddle, Registered Land Surveyor, of properties formerly belonging to H. P. Beam with reference being made here to the original survey dated August, 1954. Said parcel of land begins in the center of S. C. Highway No. 8 at corner of lands now owned by J. R. Davis and runs along center of said Highway N. 69-05 W. 311.7 feet to corner in road; thence S. 31-25 W. 375 feet to corner on lands of J. R. Davis; thence along line of Davis lands S. 43 W. 577.2 feet to iron pin; thence continuing along Davis' line N. 8-58 E. 597 feet to southern edge of Highway No. 8; thence N. 6-27 W. 40.3 feet to beginning corner; in or near center of Highway No. 8, and being bounded on the North and West by lands of Lula Burns, and on the East and South by lands of J. Bennett, et al, dated January 5, 1932, and recorded in R.M.C. office for Greenville County in Vol. 160, at page 60; also Power of Attorney dated January 5, 1932, recorded in Vol. 164 at page 161; also a part of the lands of the Mrs. T. B. Bennett Estate, and was allotted to the said Julia A. Garrison, and the same conveyed to her by C. H. Bennett, T. C. Bennett and J. T. Bennett, attorneys-in-fact, by deed dated January 11, 1934, and recorded in Book of Deeds 178, at page 413.
