All that certain lot of land in Greenville County, State of South Carolina, BEGINNING on an iron pin in old road, formerly General Pierce land, running thence with said land North 48-45 West 312 1/2 feet to iron pin; thence North 59-00 East 230 6/10 feet to iron pin in new road (iron pin reference at South 59-West 30.6 feet); thence South 6-30 East 326.6 feet to the BEGINNING containing 4/5 acres more or less, this being part of the land deeded me by deed Volume 267, Page 189.
