ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, now within the coprorate limits of the City of Greenville, South Carolina, and is known and designated as Lot 42 of a subdivision known as Sherwood Forest as shown on Plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book BB at pages 30 and 31, and having the following metes and bounds, to-wit:
