TO ALL WHOM THESE PRESENTS MAY CONCERN: DONALD C. TUMBLIN

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twelve Thousand, Eight Hundred and No/100ths----- DOLLARS (\$ 12,800.00), with interest thereon from date at the rate of Six----- per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, January 1, 1991

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northeastern side of Theodore Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 8 as shown on a plat of Carolina Heights, prepared by Dalton & Neves, dated August 1964, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 29, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Theodore Drive at the joint front corner of Lots Nos. 7 and 8, and running thence with the line of Lot No. 7 N. 41-38 E. 152.2 feet to an iron pin in the subdivision property line; thence with the said subdivision property line N. 48-52 W. 105 feet to an iron pin on the Southeastern side of an unnamed street; thence with the Southeastern edge of said unnamed street S. 4-38 W. 126.4 feet to an iron pin at the intersection of said unnamed street and Theodore Drive; thence with the corner of the intersection the chord of which is S. 3-22 E. 35.3 feet to an iron pin; thence with the Northeastern side of Theodore Drive S. 48-22 E. 80 feet to the point of beginning.

This being the identical property conveyed to the mortgagor herein by deed of Fred P. Gibson of even date herewith and recorded in the R.M.C. Office for Greenville County, South Carolina.
