TO ALL WHOM THESE PRESENTS MAY CONCERN: JANE L. SHAW

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand, Eight Hundred and No/100ths-----
DOLLARS (\$ 3,800.00), with interest thereon from date at the rate of Six and one-half per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Gordon Street near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as the rear portion of Lot No. 8 on a plat entitled "Property of Eliza T. Looper" by R. E. Dalton, Engineer, dated December 1924 and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book H at page 159-160 and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Northern side of Gordon Street at a point 150 feet east of the Northeastern point of intersection of Gordon Street with Washington Avenue, said point being at the joint front corner with Lot No. 7; thence with the said line of Lot No. 7 N. 22-0 W. 58 feet to an iron pin at the joint rear corner with the Lot No. 9; thence with the joint line of Lot No. 9 S. 71-17 W. 50 feet to an iron pin; thence with a new line through Lot No. 8 S. 22-0 E. 58 feet to an iron pin on the Northern side of Gordon Street; thence with Northern side of Gordon Street N. 71-17 E. 50 feet to the point of beginning.

This being the identical property conveyed to the mortgagor herein by deed of W. N. Leslie, dated 21, 1960, and recorded in the R.M.C. Office for Greenville County, South Carolina, on December 22, 1960 in Deed Volume 665 at page 143.
