- 5. That Mortgagor (i) will not remove or demolish or alter the design or structural character or any building low or herecondition and repair; (iii) will not commit or suffer waste thereof; (iv) will not cut or remove nor suffer the cutting or removal
  of any trees or timber on the premises (except for domestic purposes) without Mortgagee's written consent; (v) will comply with
