(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----
Four Thousand Six hundred Fifty and no/100----- DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, situate on the western side of Watson Avenue in the City of Greenville, being shown as Lot No. 4, Block No. 7, Sheet 74 of the City Block Book, and being more particularly described as follows:

BEGINNING at an iron pin at the corner of lot now or formerly owned by W. R. Payne, and running thence with Watson Avenue, N. 18 W. 55 feet to an iron pin, corner of lot formerly owned by J. D. McNeal; thence with line of McNeal's lot, S. 71 W. 128 feet; thence approximately, S. 18 E. 55 feet to the corner of lot now or formerly owned by W. R.
