NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **at the Southwestern corner of the intersection of Hartsville Street and Orchard Drive near the City of Greenville, County of Greenville, State of South Carolina being known and designated as Lot No. 230 as shown on a final plat of Orchard Acres, Section Three prepared by J. Mac Richardson dated May, 1960 recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book QQ, page 143 and having according to said plat the following metes and bounds:**

**BEGINNING at an iron pin on the Western side of Orchard Drive at the joint front corner of Lots Nos. 230 and 231 and running thence with the line of Lot No. 231 S. 84-30 W. 179.7 feet to an iron pin in the line of Lot No. 229; thence with the line of Lot No. 229 N. 3-08 W. 106.9 feet to an iron pin on the Southern side of Hartsville Street; thence with the Southern side of Hartsville Street N. 86-39 E. 150 feet to an iron pin; thence with the corner of the intersection of Hartsville Street and Orchard Drive the chord of which is S. 49-25 E. 35 feet to an iron pin on the Western side of Orchard Drive; thence with the Western side of Orchard Drive S. 5-30E. 75 feet to the point of beginning.**
