"All of that certain tract of land situate in Oak Grove School District of Glassy Mountain Township, Greenville County, State of South Carolina, on waters of the South Pacolat River, designated As Tract #2 on a plat of the John L. Pierce Estate the same being surveyed by W. P. Morrow in October, 1952, and having according thereto the following metes and bounds:

BEGINNING at a point in the center of the Ballew Mill Road, at the joint corner with Tract #1, and running thence S.46-00 W. 1313 feet to a stake on a spring branch; thence along said branch S. 25-30 E. 377 feet to a point; thence still along said branch S. 51-00 E. 132 feet to a point; thence S. 17-00 E. 90 feet to a stake in said branch; thence N. 46-00 E. 1368 feet to the center of said Ballew Mill Road; thence along the center of said Road N. 38-30 W. 361 feet; thence N.28-00 W. 110' thence N.19W.110' to the point of BEGINNING, and containing 16.50 acres, more or less."
