And WE further agree hereby that if portion of said principal or interest shall be past due and unpaid, the whole amount evinced by this note shall, at the option of the holder thereof, become immediately due, and the said holder shall have the right to institute any proceedings upon this note and any collaterals given to secure the same, for the purpose of collecting said principal and interest, with cost and expenses, or of protecting any security connected therewith.

And WE further agree hereby that if this note be placed in the hands of an attorney for collection, or if this debt or any part thereof, be collected by an attorney, or any legal proceedings of any kind, an attorney's fee of ten per centum, besides all cost and Court expenses incident upon such collection, shall be added to the amount upon this note, and collected as part thereof.
