All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, being known as **Lot 4 of the subdivision of Club View Heights and recorded in the R.M.C. Office for Greenville County in Plat Book GG at page 145 and having according to said plat the following metes and bounds, to-wit:**
