To All Whom These Presents May Concern: I, William C. Sloan,

the Mortgagor(s), SEND GREETING: hereinafter called

WHEREAS, the said Mortgagor(s) in and by his certain promissory note in writing, of even date with these Presents, is well and truly indebted to Giles L. Bramlett

hereinafter called Mortgagee, in the full and just sum of Forty-four Hundred and Seventy (\$4470.00) - - - - - DOLLARS,

to be paid as follows: \$25.00 on February 1, 1966, and \$25.00 on the 1st day of each month thereafter until paid in full, with the privilege of paying additional amounts or all at anytime,

with no interest thereon from at the rate of per centum per annum, to be computed and paid

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee, Giles L. Bramlett and his heirs and assigns forever:

All that parcel or tract of land in Chick Springs Township, Greenville County, State of South Carolina, located about one mile northwest of the City of Greer and near the Fairview Baptist Church, lying on the northeast side of Mountain View Drive, being shown on a plat made for Giles L. Bramlett by C.O. Riddle, Surveyor, having the following courses and distances:

BEGINNING on an iron pin in the center of Mountain View Drive, the southwestern corner of the tract (iron pin on bank of street at 27 feet from true corner), and runs thence along the center of said street, N. 14-55 W. 212.7 feet to an iron pin on A.L. Talley line; thence with his line, N. 64-15 E. 837.3 feet to a stone; thence N. 63-48 E. 185.3 feet to a point in center of branch (iron pin on east bank thereof at 15 feet); thence up and with the meanders of the branch as the line, S. 17-48 W. 290 feet to corner of 3.69-acre tract (iron pin on southwest bank at 19 feet); thence with line of that tract, S. 64-15 W. 862.6 feet to a stake in the center of said street, the beginning corner, containing 4.52 acres, more or less.

This is the same property conveyed to the mortgagor herein by Giles L. Bramlett by deed to be recorded, and this is a purchase money mortgage given to secure the greater portion of the purchase price.
