And, it is hereby further understood and agreed that, notwithstanding any provision herein or in said note or any instrument securing the payment of all or any part of said in-debtedness and interest, the total liability for payments in the nature of interest shall not exceed the limits now imposed by the usury laws of the state where said mortgage is recorded and that this instrument shall be construed by the laws of said state.
