NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Fairlawn Circle and being known and designated as Lot No. 15 of Section 2 of the subdivision known as Fenwick Heights shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "QQ", at Page 45 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Fairlawn Circle, joint front corner of Lots Nos. 15 and 16 and running thence along the common line of said lots S. 20-15 E. 142.8 feet; thence across the rear line of Lot No. 15 S. 65-54 W. 163.9 feet to an iron pin; thence with the common line of Lots Nos. 14 and 15 N. 7-20 E. 199.9 feet to an iron pin on the southern side of Fenwick Circle; thence with said Circle N. 88-00 E. 75 feet to an iron pin, the point of beginning.
