RELEASE OF MORTGAGE

FOR VALUE RECEIVED, I, C. E. Robinson, as Trustee under the B. M. McGee Will, do hereby release and forever discharge a portion of that certain lot situate in the County of Greenville, State of South Carolina, Butler Township on the eastern side of Glenwood Road from the lien of that certain mortgage given to me on October 5, 1965 in the original amount of Two Thousand Five Hundred and No/100 (\$2,500.00) Dollars and recorded in the R. M. C. Office for Greenville County in Mortgage Book 1009, Page 597, being given by T. P. Golightly.

The portion of the lot being released is hereby described as follows:

"BEGINNING at an iron pin on the eastern side of Glenwood Road, at the southernmost portion of the property of the grantor situate on Glenwood Road, common corner of property of the grantor and property now or formerly of Simpson, and running thence S. 84 E. 123.8 feet to an iron pin at the corner of Cape property and property of the grantor and running thence with the common line of Cape property and that of the grantor N. 1-15 W. 60 feet to an iron pin; thence with a new line through the grantor's property S. 84 E. 129 feet to an iron pin on the eastern side of Glenwood Road; thence with the eastern side of said road S. 5-55 W. 60 feet to an iron pin on the eastern side of Glenwood Road, the point of beginning."

The remaining portion of the lot being approximately 93.7 feet on Glenwood Road, 107.2 feet on Sunnyside Lane, 49.3 feet on the northernmost corner and 35.8 feet across the rear remains subject to this mortgage, and is in no way affected by this release.
