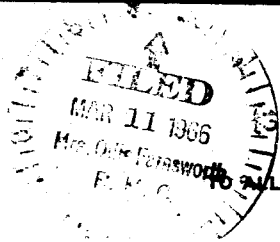

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, We, Walter R. and Bertie Donahue

(hereinafter referred to as Mortgagor) is well and truly indebted unto BARCO, INC.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty One Hundred Six and 85/100

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of Newcut Road, and being and designated as lots Nos. 4 and 25, Block A, on map of Summit View made by W. D. Neves, Engr., said map being of record in the R.M.C. Office for Greenville County, reference to which is hereby made for a more complete description.
