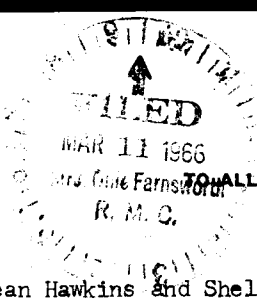

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, We, Harold Dean Hawkins and Shelby Jean Hawkins
(hereinafter referred to as Mortgagor) is well and truly indebted unto BARCO, INC:

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty Three Hundred Eighty Seven and 40/100 Dollars (\$ 2387.40)) due and payable in equal monthly installments of Fifty Six and 08/100 (\$56.08) each, first payment due and payable on the 20th day of March, 1966, and a like amount to be paid on the 20th day of each and every month thereafter for a total of forty eight (48) months until paid in full, and as more fully set forth in the real estate note executed this date,
