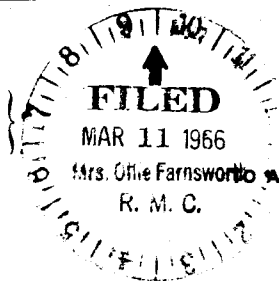

WHEREAS, We, Thomas F. Gambrell and Sara E. Gambrell

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being 1.61 acres, more or less, and shown more particularly in Volume 149, page 112, reference to which is hereby made for a more complete description.

FOR VALUE RECEIVED the undersigned does hereby grant, bargain, sell and release unto NORTH AMERICAN ACCEPTANCE CORPORATION, 1252 W. Peachtree St., N.W., Atlanta, Georgia, all its right, title and interest to the within mortgage and to the note for which mortgage is given to secure, this 23 day of February, 1966.
