TO ALL WHOM THESE PRESENTS MAY CONCERN: **Mabel Walker Williams**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Three Thousand Two Hundred and No/100** - - - - - DOLLARS (\$ **3,200.00** ), with interest thereon at the rate of **6½** per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is **five** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the northeastern side of Nelson Street in the City of Greenville, being shown and designated as Lot No. 6 on plat of property of F. M. Burnett recorded in Plat Book F at Page 216 and being more particularly described as follows:**

**BEGINNING at an iron pin on the northeastern side of Nelson Street at the joint front corner of Lot Nos. 5 and 6 and running thence with line of Lot No. 5 N. 31-50 E. 116.2 feet to an iron pin; thence S. 63-25 E. 24.5 feet to pin; thence S. 26-00 W. 118.5 feet to an iron pin on Nelson Street; thence with the northeastern side of Nelson Street N. 58-30 W. 36 feet to the point of beginning.**

Being the same property conveyed to the mortgagor under the name of Mabel Walker by deeds recorded in Deed Book 400 at Page 345 and Deed Book 468 at Page 335.
