"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that lot of land, situate on the east side of Stonehaven Drive and on the southwest side of Cleveland Street Extension, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 35 on plat of Section C-1 of Gower Estates, made by R. K. Campbell and Webb Surveying & Mapping Co., July 27, 1962, recorded in the RMC Office for Greenville County, S.
