### MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Mountain Creek Baptist Church

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Twelve Thousand -----  
DOLLARS (\$12,000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs

Township, on the north side of State Highway No. 253, and near the City of Greenville, containing 14.90 Acres, more or less, upon which the Mountain Creek Baptist Church and caretaker's residence are located, and being all of that property conveyed to said Church as follows: Deed from Jones W. Batson and Gainse N. Batson, Executors of the Estate of H.W. Batson, dated November 7, 1957, recorded in Deed Book 567, page 486, R.M.C. Office for Greenville County; deed from H.W. Batson, dated April 23, 1951, recorded in Deed Book 434, page 117, in said R.M.C. Office; deed from C.E. Robinson, Trustee, dated Sept. 5, 1941, recorded in Deed Book 236, page 424, in said R.M.C. Office; deed from J.W. Parham dated Sept. 5, 1941, recorded in Deed Book 236, page 422, in said R.M.C. Office; deed from John W.
