TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Mary P. Campbell

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South-east side of a public road which runs from Landrum to Belue Mill, in Glassy Mountain Township, and having the following courses and distances, to-wit: Beginning at a point in said road and running thence S. 46 E. 210 feet to a Stake, thence S. 44 W. 210 feet to a Stake, thence N. 46-05 W. 209.7 feet to a point in said road (Stake back on line at 27 feet), thence with said road N. 44 E. 210 feet to the beginning point. This being the same property which was conveyed to mortgagor herein by Harvey Pitman by deed dated Feb. 11, 1966, which deed will be recorded forthwith in the R. M. C. Office for said County.
