SEND GREETING:

Whereas, I, the said Joe E. Gambrell  
in and by my certain Real Estate note in writing, of even date with these  
Presents, am well and truly indebted to Barco, Inc.  
in the full and just sum of Six thousand fifty-two and 25/100 (\$6,052.25)  
Dollars, to be paid in 60 equal, monthly payments of \$116.99,  
commencing on the 20th day of May, 1966, and continuing on the 20th  
day of each month thereafter until paid in full, said payments to  
be applied first to interest and then to principal

, with interest thereon from date  
at the rate of six per centum per annum, to be computed and paid monthly  
until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and  
unpaid, the whole amount evidenced by said note to become immediately due, at the option of the  
holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its  
maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity  
it should be deemed by the holder thereof necessary for the protection of his interests to place and

South Carolina, known and designated as Lot 42, Country Club  
Estates, as shown on a plat thereof recorded in the R.M.C. Office  
for Greenville County in Plats Book G, Pages 190 and 191.
