TO ALL WHOM THESE PRESENTS MAY CONCERN: M. G. Proffitt, Inc.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----  
**Twenty-Two Thousand One Hundred and No/100-----DOLLARS**  
(\$ 22,100.00 ), with interest thereon at the rate of 6 1/4 per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Charlburg Street in the City of Greenville being shown as Lot No. 23 on a plat entitled Section F of Gower Estates, recorded in Plat Book JJJ at Page 99, and described as follows:

BEGINNING at an iron pin on the eastern side of Charlburg Street at the corner of Lot 24, and running thence with the eastern side of said Lot S. 19-50 E. 115 feet to an iron pin at the corner of Lot 25; thence with the line of said Lot N. 70-04 E. 179.7 feet to an iron pin; thence N. 19-50 W. 115 feet to an iron pin at the corner of Lot 24; thence with the line of said Lot S. 70-04 W. 179.9 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
