MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Mildred T. Stanford and Rachel T. Wilson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- Six Thousand and No/100----- DOLLARS (\$ 6,000.00), with interest thereon at the rate of 6 1/4 per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of the intersection of Otis Street and Ladson Street in the City of Greenville, being shown as Lot No. 1 on plat of the Property of Parrish and Gower, recorded in Plat Book F at Page 49, and having the following metes and bounds:

BEGINNING at an iron pin, corner of Ladson and Otis Streets, and running thence along Ladson Street, S. 35-32 E. 56 feet to an iron pin, joint corner of Lot No. 2; thence with line of Lot No. 2, S. 54-28 W. 150 feet to an iron pin in line of Lot No. 4; thence with line of said Lot N. 31-39 W. 100.5 feet to an iron pin on Otis Street; thence with the southeastern side of Otis Street, N. 71-35 E. 150 feet to the point of beginning.
