(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Fifteen Thousand Seven Hundred and No/100** - - - - - DOLLARS (\$ 15,700.00 ), with interest thereon at the rate of **Six and one-fourth** per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is **15** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the western side of Ravensworth Road near the City of Greenville being shown as Lot 15 of plat of Brook Glenn Gardens recorded in Plat Book JJJ at Page 85 and described as follows:**

**BEGINNING at an iron pin on the western side of Ravensworth Road at the corner of Lot No. 14 and running thence with the western side of said lot S. 29-43 E. 110 feet to an iron pin at the corner of Lot No. 16; thence with the line of said lot S. 60-17 W. 150 feet to an iron pin; thence N. 29-43 W. 110 feet to an iron pin at corner of Lot No. 14; thence with the line of said lot N. 60-17 E. 150 feet to the beginning corner.**
