MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Marietta M. Bolt, Sue S. Hahn and Helen D. Fincher
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto

Alice LeGrand Mills

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand and No/100---

-----DOLLARS (\$ 5,000.00),

with interest thereon from date at the rate of 6 1/4 per centum per annum, said principal and interest to be repaid:

PAYABLE: \$55.00 per month beginning on the 5th day of July, 1966 and a like payment on the 5th day of each succeeding month thereafter until paid in full.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being shown as Lot No. 84 on a plat of Pleasant Valley Subdivision, made by Dalton and Neves, Engineers, in April, 1946, with revisions and additions recorded in Plat Book BB at Page 163 in the R.M.C. Office for Greenville County.

Being a portion of the property conveyed to the mortgagors by deed of Robert L. Watkins, Jr., by deed recorded in Deed Book 786 at page 469.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
