WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **situate on the southeast side of Yorkshire Drive (formerly known as Mable Avenue), near the City of Greenville in Greenville County, South Carolina, being shown as Lot No. 259 on plat of property of Robert J. Edwards, recorded in the RMC Office for Greenville County, S.C., in Plat Book EE, page 61, said lot fronting 125 feet along the southeast side of Yorkshire Drive, and running back to a depth of 200 feet on the northeast side to a depth of 200.1 feet on the southwest side of said lot along Cherokee Drive and being 120.3 feet across the rear.**
