Spartanburg, S. C., hereinafter called the Mortgagor, are well and truly indebted to SHELL HOMES, INC., hereinafter called the Mortgagee, in the full and just sum of Seven Thousand One Hundred Forty & No/100 Dollars, evidenced by a certain promissory note in writing of even date herewith, which note is made a part hereof and herein incorporated by reference, payable in 120 monthly installments of Fifty Nine & 50/100 Dollars each, the first installment being due and payable on or before the 1st day of December, 1964, with interest at the rate of six per cent. (6%) per annum from the date of maturity of said note until paid, and said Mortgagor having further promised and agreed to pay ten per cent. All that lot or parcel of land located about one mile East of Taylors, Greenville County School District No. 9-D, Brushy Creek Community and being a part of that property deeded to T. C. Brewton and recorded in Deed Book 467 at page 386 and further shown on plat made for Albert E. and Betty Brewton by W. N. Willis, Engineers dated August 17, 1964 and described as follows:

Beginning on an iron pin on South side of County Road, about 260 feet Northwest of outside property line and fence corner; thence S. 26-41 E. 220 feet to iron pin; thence N. 89-00 W. 210 feet to iron pin; thence N. 26-41 W. 220 feet to iron pin on South side of said County Road; thence along said County Road, S. 89-00 E. 210 feet to point of beginning and containing One acre (1.0), more or less.

The above described land is intended to be and shall include the parcel of land upon which Shell Homes, Inc., will build a Spartanburg type Shell Home in or about August, 1964, for Albert E. Brewton and Betty Brewton. Sometimes known as Albert E. Bruton and Betty Bruton.
