(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Twenty Five Thousand and no/100----- DOLLARS
(\$ 25,000.00---), with interest thereon at the rate of Six and one-fourth cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the North-east side of Charlbury Street in the City of Greenville, being shown as Lot 21 on a plat of Gower Estates, Section 5, dated November, 1965, prepared by R. K. Campbell and Webb Surveying and Mapping Company and recorded in Plat Book JJJ at page 99, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeast side of Charlbury Street at the joint front corner of Lots 21 and 22 and running thence with the line of Lot 22, N. 70-04 E. 179.5 feet to an iron pin at the joint rear corner of Lots 21 and 22; thence S. 10-50 E. 110 feet to an iron pin at the joint rear corner of Lots 20 and 21, S. 70-04 W. 179.3 feet to an iron pin on Charlbury Street; thence with said Street, N. 19-56 W. 110 feet to the point of beginning.
