**Sherman H. Floyd and Christine D. Floyd**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

**Eighteen Thousand and no/100-----** DOLLARS  
(\$18,000.00), with interest thereon at the rate of **Six and one-fourth** per cent per annum as

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **situate on the Eastern side of Hialeah Road in the City of Greenville and shown and designated as Lot 357 of Section B on plat of Gower Estates recorded in Plat Book XX at pages 36 and 37, and having according to said plat the following:**

**BEGINNING** at an iron pin on the Eastern side of Hialeah Road at the joint front corner of Lots 357 and 358; and running thence with line of Lot 358, S. 87-25 E. 175 feet to a pin; thence N. 2-35 E. 100 feet to a pin at the rear corner of Lots 356; thence with the line of Lot 356, N. 87-25 W. 175 feet to a pin on Hialeah Road; thence with the Eastern side of said Road, S. 2-35 W. 100 feet to the point of Beginning.
