"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **situate on the North side of Pimlico Road in the City of Greenville, shown and designated as Lot 455 on a plat of Section D of Gower Estates, recorded in Plat Book RR at pages 192 and 193, and having according to said plat the following metes and bounds:**

BEGINNING at an iron pin on the Northern side of Pimlico Road, joint front corner of Lots 455 and 454 and running thence with the line of Lot 454, N. 14-40 W. 216.6 feet to a pin; thence N. 59-05 E. 134.2 feet to a pin at rear corner of Lot 456; thence with the line of Lot 456 and drainage easement S. 15-45 E. 215.5 feet to a pin on Pimlico Road; thence with the Northern side of said Road, S. 51-16 W. 84.7 feet; thence continuing with said Road, S. 61-08 W. 58.6 feet to the point of Beginning.
