All that certain piece, parcel or lot of land in Glassy Mountain Township, Greenville county, State of South Carolina, being known and designated as Lot 7 as shown on plat made for J. Calhoun dated April 4, 1959, made by J. Q. Bruce and recorded in Plat Book 00 at page 360 and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Northeastern margin of Lanier Drive, said iron pin being located near a power line pole and being the joint front corner of Lots 6 and 7 and running thence with the line of Lot 6, North 66-37 East 243.3 feet to pin; thence South 23-23 East 100 feet to iron pin at corner of Lot 8; thence with line of said lot, South 66-37 West 245.3 feet to iron pin on Lanier Drive; thence with the Northeastern side of Lanier Drive, North 22-15 West 100 feet to the point of BEGINNING.
