All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **near the City of Greenville, County of Greenville, State of South Carolina, and being known and designated as Lot No. 130 part of AVON PARK, according to plat prepared by C. C. Jones, dated December 1956 and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "KK" at page 71, and having, according to said plat the following metes and bounds, to wit;**
