all that tract or lot of land in Township, Greenville County, State of South Carolina, being Lot No. 1: All that certain parcel and lot of land situate, lying and being in ward 1 of the City of Greenville, and being described as follows:

Beginning at a point on Pine Street and running thence in a westerly direction, along line of St. Peter's Colored Church 66 feet, more or less, to line of Perry Garrett; thence in a northerly direction along line of Perry Garrett 25, more or less, to a stake; thence in a easterly direction along parallel line with the first line above mentioned 66 feet, more or less to Pine Street; thence in a southerly direction along Pine Street 25 feet, more or less to the beginning.
