M. C. Office for Greenville County in Plat Book "EE", at Page 130. Said lot fronts 90 feet on the south side of Derwood Lane and runs back to a depth of 195.4 feet on the east side and to a depth of 185 feet on the west side and is 125.9 feet across the rear.
