Whereas, we, the said D. R. BOSTICH and RACHEL S. BOSTICH

, to be paid in monthly installments of Ninety-Five &
00/100 Dollars (\$95.00), beginning on the first day of September, 1966
and a like payment on the first day of each month thereafter until the
entire indebtedness together with interest shall have been paid in
full, with interest thereon from date
at the rate of 6 per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and
unpaid, the whole amount evidenced by said note to become immediately due, at the option of the
holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its
