of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his  
account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly  
paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted,  
bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and  
being in the State of South Carolina, County of Greenville, on the northeastern side of Ivydale Dr.  
(Formerly Churchill Ave.), and known and designated as Lot No. 110 of a subdivision  
known as Piedmont Heights, Plat of which is recorded in the RMC office of Greenville  
County in Plat Book "M" at page 123, and according to said plat has the following metes  
and bounds to wit:

Beginning at an iron pin on the northeastern side of Ivydale Dri. and joint front  
corner Lots noll1 and 110 which iron pin is 420 feet west from the intersection  
of Ivydale Dr. and Omar Ave. and running thence N. 24-0 E 175 Feet to an iron pin  
on the S 66-0 E 60 feet to an iron pin; thence running s 23-0 W. 175 feet to an  
iron pin on the Northeastern side of Ivydale Dr. running thence w th the northeastern  
side of Sad Dr. N 66-0 feet to an iron pin; point of beginning.

The Frantees herein ass me and agree to pay that certain note and mortgage hereto  
for executed by Grantor herein, unto the administrator of Veterans Affairs,  
recorded in Morgage Book 736 at Page 191 and has a present balance of \$7,218.08.

together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
