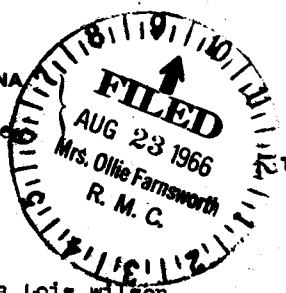

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, Dora Lois Wilson

(hereinafter referred to as Mortgagor) is well and truly indebted unto E.H. Edwards

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of one thousand and no/100 Dollars (\$ 1,000.00) due and payable

at the rate of thirty five (\$35.00) dollars each month until the principal and interest has been paid in full.

with interest thereon from date at the rate of 7 per centum per annum, to be paid: annually

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, School District 315 near Berry's Mill, on the Northern Side of the O'Neal Berry's Mill Road, being bounded (Now or Formerly) on the Northeast by B.C. Berry, South and southeast (Now or Formerly) by AL Southern, and Northwest by said road and having the following courses and distances to wit:

BEGINNING on a nail and stopper in center of said road, joint corner of B.C. Berry tract and running thence with the Berry Line S. 47-45 E. 400 feet to an iron pin on Berry's corner; thence S. 31-45 W. 156.7 feet to an iron pin, new corner; thence N. 42-10 W. 430 feet to a nail and stopper in center of said road; thence with center of said road, N. 43-05 E. 100 feet to the point of beginning, and containing 1.15 acres, more or less.

This being the same property conveyed to me by deed from Thomas Earl Edwards, recorded in R.M.C.C. office for Greenville County in Deed Book 726 at page 319

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
