WHEREAS I, Ann O. Jones, of Greenville County, am well and truly indebted to Richard F. Watson, Jr. and Evelyn P. Watson in the full and just sum of Seven Thousand, Three Hundred Fifty and No/100----- (\$ 7, 350.00) Dollars, in and by my certain promissory note in writing of even date herewith, due and payable as follows: Two Thousand, Four Hundred Fifty and No/100 - (\$ 2, 450.00) Dollars on September 1, 1967, Two Thousand, Four Hundred Fifty and No/100 - (\$ 2, 450.00) Dollars on September 1, 1968, and Two Thousand, Four Hundred Fifty and No/100 (\$ 2, 450.00) Dollars on September 1, 1969, with the privilege of anticipating payment of the entire principal debt or any part thereof at any time prior to maturity, without penalty, upon payment of the principal balance due at date of payment plus interest computed to that date,

with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid annually and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Ann O. Jones

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Richard F. Watson, Jr. and Evelyn P. Watson, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 22 of a subdivision of the property of the mortgagees as shown on a preliminary plat thereof prepared by Piedmont Engineers and Architects, and having, according to a plat entitled "Property of Ann O. Jones" prepared by Piedmont Engineers and Architects August 26, 1966, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Highbourne Drive, joint front corner of Lots Nos. 21 and 22, and running thence with the joint line of said lots, N. 15-03 E. 223.75 feet to an iron pin; thence S. 77-23 E. 355.03 feet to an iron pin at the joint rear corner of Lots Nos. 22 and 24; thence with the joint line of said lots, S. 13-50 W. 220.8 feet to an iron pin on the northern side of Highbourne Drive; thence with the northern side of Highbourne Drive, N. 77-50 W. 360.0 feet to the beginning corner; being the same conveyed to me by Richard F. Watson, Jr. and Evelyn P. Watson by deed of even date, to be recorded herewith.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the same belonging or in any way incident or appertaining, including all heating, plumbing and electrical fixtures, and any other equipment or fixtures now or hereafter attached, connected or fitted in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than household furniture, be considered a part of the realty.

Richard F. Watson, Jr. and Evelyn P. Watson, their Heirs and Assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said mortgagee, their Heirs and Assigns, from and against me, my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.
